

## **Grant funding opportunities for myPlaybook**

### **1. Conference grants**

- a. These monies must be used to maintain programs and services in five areas. Drug Education is one of these areas.
- b. The conference can grant sub grants to member institutions for specific programs. The conference must ask the NCAA for their grant money. The institution must ask the conference for the grant money.
- c. Division I Conference Grants
  - i. Grants are available to Division I basketball-playing conferences that employ a full-time administrator and are eligible for automatic qualification into the Division I men's and women's basketball championships. Basketball-playing conferences that do not sponsor both men's and women's basketball receive a lesser grant amount.

- d. Division II Conference Grants
  - i. Division II conference offices are eligible to receive a base amount of \$85,000, with the remaining grant balance distributed in a set premium amount based on the number of institutions in the conference during the academic year the grant application is submitted.

- c. \$30,000 grant over a 3-year period

- c. 15, \$2,500 grants conference offices association wide
- d. Applications are approved on a first come, first serve basis
